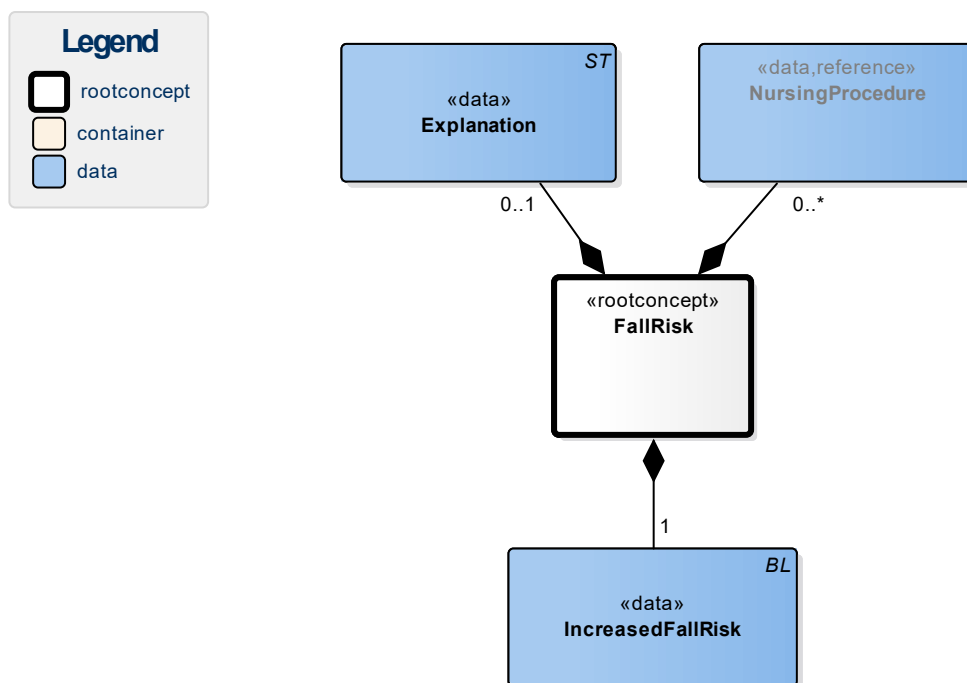
1.4 Purpose
