This includes not only caregivers, but also professional help such as that offered by home care organizations, nurses, aids and helpers.

Current doctors and staff from the facility to which a patient is admitted do not fall under this concept.


1.4 Purpose

If this care is not sufficiently available, measures can be taken to facilitate the required care. This plays a particularly important role in for example discharges from the hospital or from a nursing home.
