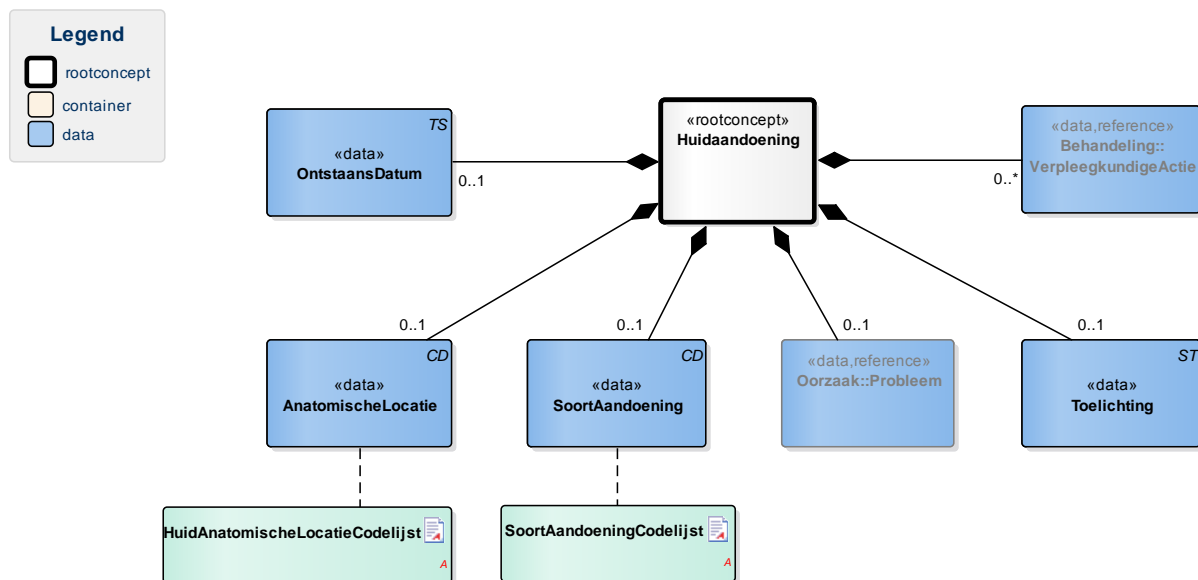
are recorded in the problem list.

The reason for this is that there are many types of skin conditions that are almost always recorded as free text in the current situation. For this purpose, the concept offers the option to choose 'Other' in which the skin condition can be entered in free text. This code list can be expanded when skin conditions are recorded in a more structured way.
