1.3 Mindmap

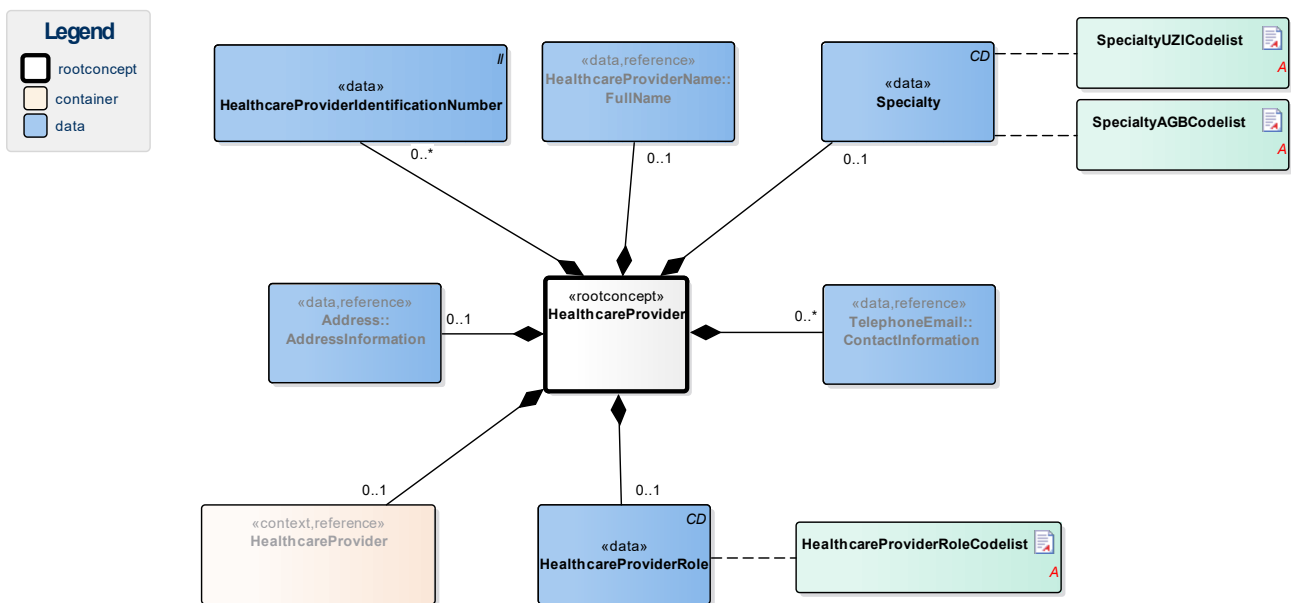
1.4 Purpose
