Information on the skin condition is of importance for determining or continuing the required care. Specific expertise or materials can be facilitated in the event that a patient is transferred.


Any underlying medical afflictions causing the skin condition are not described in this concept but are recorded in the problem list.

For this purpose, the concept offers the option to choose 'Other' in which the skin condition can be entered in free text. This code list can be expanded when skin conditions are recorded in a more structured way.
