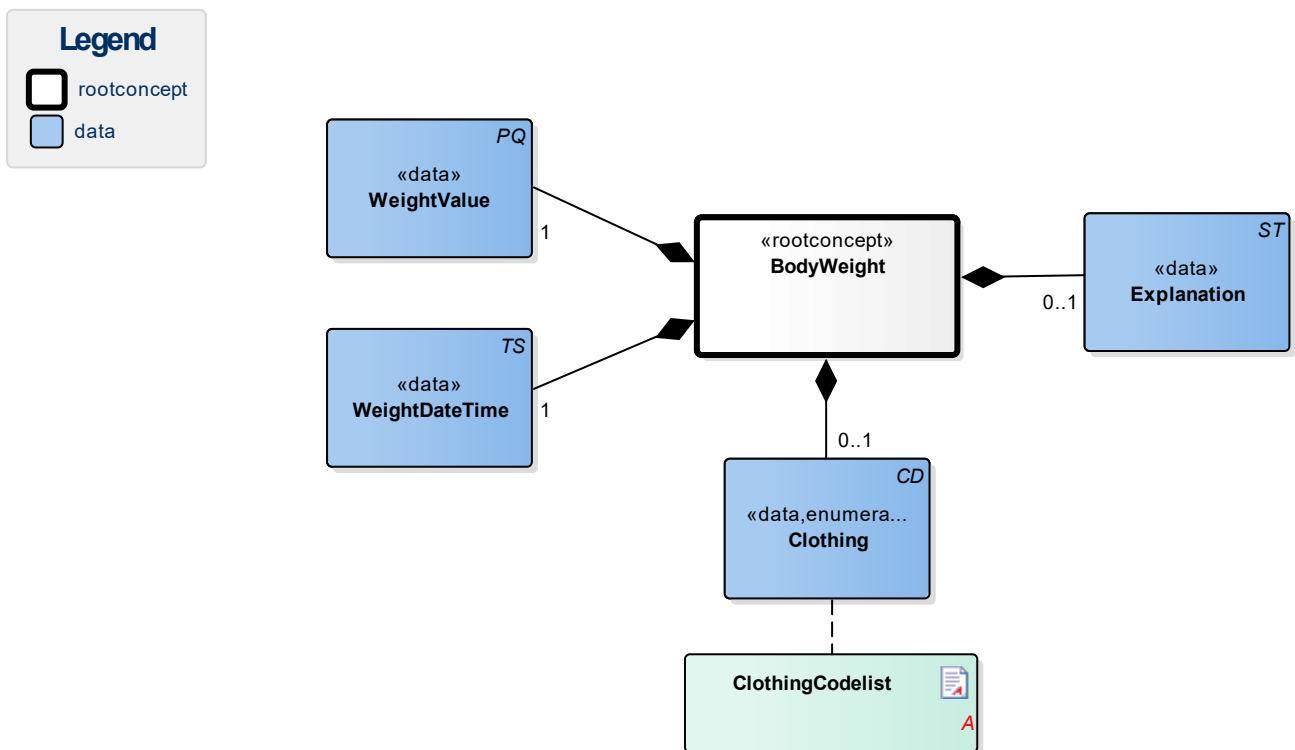

Definitie	The patient’s body weight. Body weight is expressed in kilograms (kg). For infants under 3kg, body weight is often expressed in grams. This concept can also be used to determine an estimated body weight in the event that measuring the exact body weight is not possible - such as for example weighing a resistant child, or in the case of having to estimate the weight of an unborn child.
